BENCHMARKING

2021 Worksite Health Center Benchmarking Survey Results

This year's NAWHC - Mercer Worksite Health Center national survey found that employers' focus on comprehensive, quality care continues to influence services provided by the clinic.

- Over 2/3 (71%) of employer survey respondents allow members to select the clinic as their primary care provider. On average, 40% of utilizing clinic users select the clinic as their PCP.
- Most survey respondents (80%) leverage their clinics to screen for behavioral health conditions and more than half follow-up with members who have BH needs
- Clinical teams proactively call members to close gaps in care in 67% of respondent clinics
- Health analytics help guide patient care in over half of clinics
- About a fourth (28%) of respondents' clinics have real-time integration with the local community health system – i.e., to allow the clinic staff to be notified if a member uses an ER or is admitted to a hospital.

RESEARCH

Healthy Hearts in Manufacturing

NAWHC has joined Northwestern University's Research Program on Manufacturing and Health in a new research project proposal for improving heart health and reduce disparities in cardiovascular care through employer health centers.

If you're interested in receiving FREE clinical training for your health center staff, Northwestern is currently recruiting worksite and near-site health clinics to participate in a new program. Participating clinics will be provided with *no-cost* evidence-based coaching, electronic health record support, and data feedback and benchmarking. All interventions are drawn from the [Million Hearts Campaign](#), a federally funded initiative to prevent 1 million heart attacks and strokes within 5 years. Northwestern's research team will evaluate the effectiveness of the Million Hearts interventions on patient outcomes and health care costs. MARKET DEVELOPMENTS

Phifer Incorporated Receives 2021 Employer/Purchaser Excellence Award



NAWHC Member Phifer Incorporated, a privately owned manufacturing company in Tuscaloosa, AL, was a recipient of the *2021 Employer/Purchaser Excellence Award*. Phifer is the world's largest producer of aluminum and fiberglass insect screening and has 2,800 covered lives. The company was recognized for efforts to develop a new adaptive healthcare strategy and use of its worksite health center to address stagnant healthcare metrics and an unsustainable cost curve. Through an advanced primary care initiative, plan members have better access to primary care, with a 21% increase in visits in 2020. Phifer also reduced out of pocket costs for employees by 52% and developed an employee retirement readiness program tied to both health and wellness.

Premise Expanding its Near-site Health Center Product

Premise Health announced plans to expand its near-site health and wellness services in 10 markets across the US. The markets included as part of this expansion are New York City, San Francisco, Washington DC, Chicago, Atlanta, Houston, Dallas Fort-Worth, Boston, Los Angeles and Phoenix. Premise Health currently has near-site wellness centers in more than 45 markets. With this expansion, the company will have more than 140 near-site wellness centers. These centers complement onsite wellness centers located in more than 300 metropolitan markets and 24/7, nationwide digital health.
